CIRCULAR

An online portal for Post-Retirement Medical Scheme (PRMS) for eligible ex-employees is functional and is available at Retired Employee Desk section on NFL's website (<u>www.nationalfertilizers.com</u>). Through this portal members of PRMS Scheme will now be able to submit their OPD Claims.

As already informed vide <u>circular dated 28.09.2022</u>, existing members of PRMS can view their profile and edit/ update their correspondence address, mobile number, email address and bank account details etc. To login, existing PRMS member should have their own valid mobile number and email-Id.

The window for lodging OPD claims for the period Jul - Dec, 2022 on the PRMS portal shall remain active between 01.01.2023 and 15.02.2023. The steps for lodging OPD claims for existing members are given below:-

- Visit NFL's website www.nationalfertilizers.com>>>>Click on "Retired Employee Desk" or type <u>https://prms.nfl.co.in</u> in URL.
- 2. Login by entering registered mobile number.
- 3. OTP shall be generated and will be received on the registered mobile number and also on the email of the member.
- 4. Enter the OTP to login.
- 5. Member will be directed to the profile page, where he/she shall validate his/her e-mail address via OTP on e-mail.
- 6. Member / User shall then be able to view or edit/update his/her Bank Account details, Mobile Number, e-mail and correspondence address.
- 7. After updating the profile, members will be able to view their dashboard, wherein they shall click on "Manage Claims". After this the member will click on "New Claim Request" to apply OPD claim.
- 8. A window will be opened where the members shall be able to enter their medical expenses such as consultation charges, medicines, test charges etc.
- 9. Members may also enter Preventive Health Checkup (PHC) expenses for self and spouse (if any).
- 10. After entering the details of medical expenses and PHC details, members will upload their existence certificate and submit the claim by clicking on "submit" button.

Other conditions regarding reimbursement of OPD expenses shall remain same as mentioned in the Corporate Office Circular NFL/CO/HR/PRMS-2022-23/OPD/1593 dated 22.06.2022.

In case of any query or assistance member may click on "**Contact Us**" Tab available on PRMS Portal by mentioning his/her employee number, e-mail address, contact number and submit to the PRMS Admin. For detailed instructions, please refer Annexure-I attached to this Circular.

It is to be noted by the PRMS members that, lodging of OPD claims shall be submitted by eligible ex-employees/ members through PRMS portal only and no requests/claims received through any other mode shall be entertained.
